In case of material release, avoid creating airborne dust while cleaning spill. Remove ignition sources and shovel or sweep into an appropriate container. Avoid breathing dust using adequate ventilation and/or NIOSH approved respirator for nuisance dust of this type.

**Handling:**

If excessive dust is created, avoid breathing dust by using adequate ventilation and/or NIOSH approved respirator for nuisance dust of this type.

**Storage:**

Store away from combustion sources.
